In continuity of order dated 09.06.2016;

On 09.06.2016, the Commission directed Sh. Ravinder Singh, ASPIO-cum-Gram Sachiv, Kanvi, Mahendergarh was furnished the information on point no. 7 of earth work regarding must roll of work no. 16 from Rajindra House to Mewati Dharamshala within five days under intimation to this Commission. The Show Cause Notice under Section 20(1) of the RTI Act 2005 issued to Smt. Mukesh Devi, the then SPIO-cum-Sarpanch, Gram Panchayat Kanvi, and Sh. Ravinder Singh, ASPIO-cum-Gram Sachiv, Kanvi,



Mahendergarh for causing delay in supplying the information. The case was fixed for hearing for today i.e. **15.07.2016 at 10:30 AM.**

2. Sh. Ravinder Singh, ASPIO-cum-Gram Panchayat, Village Kanvi, O/o Block Development & Panchayat Officer, Mahendergarh is present in person. He submits that in compliance of the Commission's order dated 09.06.2016 He furnished the information on point no. 7 of earth work regarding must roll of work on 13.06.2016.

3. Sh. Hanuman S/o Sh. Lala Ram, the appellant/applicant is not present. The Commission decides to hear the appellant through audio conference. During the conversation the appellant submits that he has received the complete information regarding against point no. 7 of earth work regarding must roll of work no. 16 from Rajindra House to Mewati Dharamshala. He also submitted that he does not to proceed further.

4. Keeping in view the facts and circumstances and, the Commission observes that Sh. Ravinder Singh, ASPIO-cum-Gram Panchayat, Village Kanvi was busy in the Gram Panchayat Election. It was very busy period for him. The record was not in his custody. He further submitted that as and when he was entrusted with the work of ASPIO, he immediately submitted the information sought by the appellant/applicant.

5. In view of the above, the Show Cause Notice under Section 20(1) of the RTI Act 2005 issued to Smt. Mukesh Devi, the then SPIO-cum-Sarpanch, Gram Panchayat Kanvi, and Sh. Ravinder Singh, ASPIO-cum-Gram Sachiv, Kanvi, Mahendergarh is hereby dropped.
