ORDER

In pursuance of the notification No. 5/4/2002-1AR, dated 03-09-2012, Maj. Gen.(Retd.) Jagbir Singh Kundu, AVSM, Shri Sajjan Singh, IAS (Retd.) and Shri Prahlad Rai Meena, IPS (Retd.) were appointed as State Information Commissioner, Haryana and assumed charge of office w.e.f. 03-09-2012 (A.N.). As per Section 16(5) of the 'Right to Information Act, 2005', the salary and other allowances payable under the terms and conditions of service applicable to the State Information Commissioner(s) shall be the same as that of the Chief Secretary to the State Government. In view of this provision, Maj. Gen.(Retd.) Jagbir Singh Kundu, AVSM, Shri Sajjan Singh, IAS (Retd.) and Shri Prahlad Rai Meena, IPS (Retd.), State Information Commissioners, Haryana are entitled to the following facilities w.e.f. 04-09-2012 :

1) Tenure :

As per Section 16(2) of the Act, they will hold office with effect from 03rd September, 2012 (A.N.) for a term of five years from the date on which they enters upon their office or till they attains the age of 65 years.

2) Removal of State Information Commissioner :

As stipulated in Section 17 of the Right to Information Act, 2005.

3) Salary, Allowances and other facilities :

To be paid as per section 16(5)(b) of the Right to Information Act, 2005.

4) Accommodation :

They will be entitled to Government accommodation of the same category and under the same terms & conditions to which the Chief Secretary to Government, Haryana is entitled for the purpose of retention or allotment of such accommodation. In case they do not avail of official accommodation they will be entitled of House Rent Allowance on same terms and conditions.

5) Conveyance :

As per Section 16(5) of the Act, they will be entitled to an air-conditioned car on the same conditions as is admissible to Chief Secretary to Government, Haryana.

6) **T.A./L.T.C. :**

As per section 16(5) of the Right to Information Act, 2005, they will be entitled to receive allowances to reimburse them for traveling on duty as is admissible to the Chief Secretary to Government, Haryana as amended from time to time. They will also be entitled to L.T.C. as is applicable to the Chief Secretary to Government, Haryana. The powers to grant of L.T.C. shall vest with His Excellency, the Governor of Haryana.

7) **Medical Reimbursement :**

As per section 16(5) of the Right to Information Act, 2005, they as well as members of their family dependent on them will be entitled to facilities per the provision of the All India Services (Medical Attendance) Rules, 1956 and the instructions issued there under by the Government of India/Government of Haryana.

8) **Headquarter :**

The Headquarter of State Information Commissioner, Haryana will be at Chandigarh or at any place that may be fixed by the competent authority.

9) **Other Terms & Conditions :**

As per section 16(5) of the Right to Information Act, 2005, other terms and conditions of State Information Commissioner, Haryana not specifically mentioned above, shall also be at par with the Chief Secretary to Government, Haryana.


