This matter came up for hearing in pursuance of the earlier orders passed by the Larger Bench of the Commission consisting of Smt. Urvashi

Gulati, State Information Commissioner; Maj. Gen. (Retd.) J.S.Kundu, State Information Commissioner; and Shri Yoginder Paul Gupta, State Information Commissioner in Appeal Case No.1947 of 2014 on 11.11.2016 vide which the Larger Bench had directed the SPIO-cum-Superintendent, Services-I Branch of the office of the Chief Secretary to Government, Haryana, Personnel Department and the SPIO-cum-Superintendent Home-I Branch of the office of the Addl. Chief Secretary to Government, Haryana, Home Department to furnish point-wise certified information including copies of FIR registered against IAS, HCS, IPS and HPS officers under the Prevention of Corruption Act, 1988 during the last five years to the appellant within thirty days and send compliance report to the Commission by 15.12.2016. The case was adjourned to 21.12.2016. The SPIO-cum-Superintendent Services-I Branch and the SPIO-cum-Superintendent Home-I Branch have submitted their compliance report vide letters dated 6.12.2016 and 9.12.2016 respectively which are taken on record.

2. The SPIO-cum-Superintendent Services-I Branch submitted during hearing that information on the basis of available record of the public authority was furnished to the appellant vide letter dated 6.12.2016 in compliance with directions of the Commission dated 11.11.2016.

3. The SPIO-cum-Superintendent Home-I Branch submitted during hearing that information on the basis of available record as received from the Director General of Police has been furnished to the appellant vide

letter dated 9.12.2016 through registered post in compliance with the Commission's directions dated 11.11.2016.

4. The appellant is neither present during hearing nor has sent any communication pointing out any deficiency in the furnished information.

5. The Larger Bench heard carefully the averments of the respondents and perused the record of the case file. The compliance made by the respondent SPIO was noted. The Larger Bench observes that the respondent SPIOs have furnished information to the appellant on the basis of available record of the respondent public authorities vide letters dated 6.12.2016 and 9.12.2016 through registered post. Nothing has been heard from the appellant.

6. In view of the above findings, the appeal is disposed of and the matter is closed.
